

## Agri Bulk Fuels Promotion 2023 - Terms and Conditions

READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING. YOU WILL BE DEEMED TO HAVE ACCEPTED THESE TERMS AND CONDITIONS AND AGREED TO BE BOUND BY THEM WHEN PARTICIPATING IN THIS PROMOTION. AMONG OTHER THINGS, THESE TERMS AND CONDITIONS INCLUDE LIMITATIONS OF YOUR RIGHTS AND REMEDIES.

1. The Promoter of this offer is Certas Energy Limited (Company number 4168225) of 1st Floor Allday House, Warrington Road, Birchwood, United Kingdom, WA3 6GR ("Promoter").

2. This offer is open to the Promoter's customers who are directly sent promotion codes from the Promoter ("Promotion Codes"). The Promotion Codes must then be quoted by the customer when making an order with the Promoter. All Promotion Codes are applied to the value of the order, excluding delivery costs and are subject to the Promoter's general terms and conditions.

3. To be eligible to obtain the benefits of the promotion, you must:

- a. comply with these terms and conditions;
- b. have received Promotion Codes directly from the Promoter;
- c. order the Products (as defined below);
- d. make an order to the volume of 1,000 litres or more with such order being accepted by the Promoter in accordance with the Promoter's terms and conditions of sale referred to below.

(together the "Eligibility Criteria").

e. For the avoidance of doubt, to meet the Eligibility Criteria the order must be placed in one transaction; multiple individual orders will not meet the Eligibility Criteria.

4. The Products mean:

- a. For standard fuels:  
First order, use code FUEL20 to redeem £20.00 off a single order of 1,000 litres of fuel or above.
- b. For HVO and GTL fuels:  
First order, use code REFUEL30 to redeem £30.00 off a single order of 1,000 litres of fuel or above.

The price of the Products shall those advertised, quoted or otherwise agreed with a customer at the time of placing an order that meets the Eligibility Criteria. The Promoter reserves the right to amend the price of any Products at its sole discretion at any time throughout the Promotion Period.

5. If you meet the Eligibility Criteria, then you will receive a discount amounting to the value of the code use, as stated above, to which the Eligibility Criteria applies (the "Offer").

6. By submitting to the promotion, you confirm that you are eligible to do so and eligible to claim any offer. The Promoter may require you to provide proof that you are eligible to enter the promotion.

7. The Customer will receive six Promotion Codes. The Customer will not be able to use a Promotion Code more than once. For the avoidance of doubt if a customer orders multiple products with the Promotion Code which meet the Eligibility Criteria (as set out above), they will only be eligible to receive one Offer in respect of each code.
