

**ENERGY SAVING QUIZ Terms and Conditions – Please note, this competition is now closed as of 01.11.2023 and these T&C's are no longer live**

1. The Promoter of this competition is Certas Energy UK Limited ("Promoter").
2. This competition is open to the Promoter's customers and prospective customers in the UK aged 18 years or over, excluding employees and their immediate families of Certas Energy and its associated companies in the DCC PLC group, its agencies or anyone else professionally connected with the competition.
3. To enter the competition, you must complete a quiz hosted on the Certas Energy website – [www.certasenergy.co.uk](http://www.certasenergy.co.uk), which will be set live on Thursday 21<sup>st</sup> September 2023 at 4pm. Your submission of an entry will be deemed to be acceptance of these terms and conditions and any other requirements set out in the promotional material as if they were set out in these terms and conditions.
4. To be eligible to be entered into the draw, you must complete the quiz hosted on the Certas Energy website entitled "Beyond the Grid Energy Saving Quiz". No purchase is necessary to enter the competition.
