- 2. This competition is open to the Promoter's domestic customers and prospective customers in the UK, aged 18 years or over (each a "Participant"), excluding employees and their immediate families of the Promoter and its associated companies in the DCC PLC group, its agencies or anyone else professionally connected with the Promoter.
- 3. To enter the competition, the Participant must complete the required fields on the competition page entitled "Beyond the Grid Energy Saving Tips" on the Certas Energy website (<u>www.certasenergy.co.uk</u>), or send their name, address and marketing preferences to the Promoter's address set out above. - 5. Each Participant's submission of a Tip (defined below) will be deemed to be acceptance of these terms and conditions and any other requirements set out in the promotional material, as if they were set out in these terms and conditions.
- 6. To be eligible to obtain the benefits of a Prize, each Participant must:
