

January 2024 Not Ready To Order - Terms and Conditions

1. The Promotor of this competition is Certas Energy UK Limited ("Promotor").
2. This competition is open to the Promoter's customers and prospective customers in the UK aged 18 years or over, excluding employees and their immediate families of Certas Energy and its associated companies in the DCC PLC group, its agencies or anyone else professionally connected with the competition.
3. To enter the competition, you must complete the required fields on www.certastankfill.co.uk which will be set live on Thursday 4th January 2024 at 7am. Your submission of an entry will be deemed to be acceptance of these terms and conditions and any other requirements set out in the promotional material as if they were set out in these terms and conditions.
